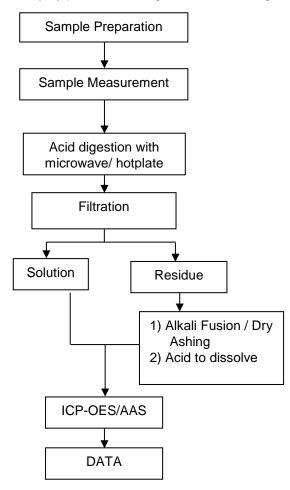

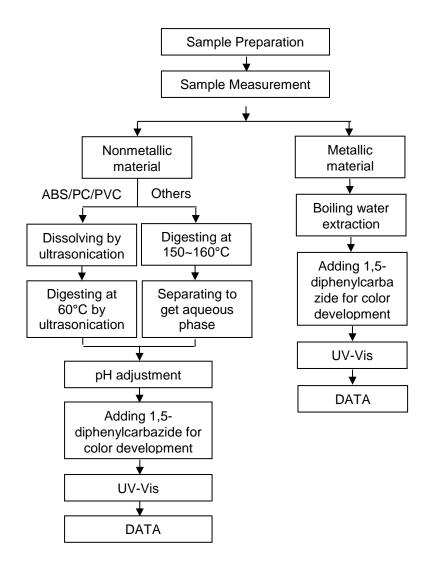

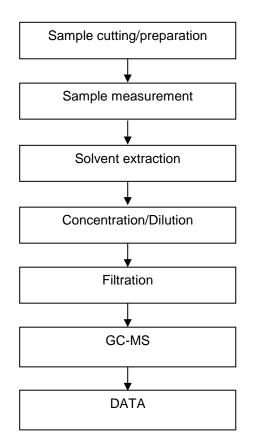

PBB/PBDE/Phthalates Testing Flow Chart


